Temporary HLL Connecting Component Compatibility Guidance

Products: 3M™ DBI-SALA® Temporary Horizontal Lifeline Systems

This is not a recall. 3M™ DBI-SALA® Temporary Horizontal Lifeline Systems remain safe to use. This is additional guidance regarding connecting component compatibility.

Recent testing and certification requirements of the new ANSI standard (ANSI/ASSP Z359.14-2021) for Self-Retracting Devices (SRDs), or Self-Retracting Lifelines (SRLs), came into effect for fall protection equipment manufacturers August 1st, 2023. As a result of the increased design and testing requirements in the latest standard revision, some of our SRL Maximum Arrest Force (MAF) and Average Arrest Force (AAF) figures have changed from SRL models certified to previous versions of the standard. These changes in arrest forces led to reduced compatibility in some cases. 3M has evaluated its Temporary HLL systems to increase compatibility and has the following additional guidance on connecting components.

The following table serves as guidance for 3M™ DBI-SALA® Temporary Horizontal Lifeline (HLL) Systems, where 3M™ DBI-SALA® SRLs manufactured to ANSI/ASSP Z359.14-2021 or after August 1st, 2023, are used.

End Users

There is no new action necessary for pre-existing 3M™ DBI-SALA® SRLs (manufactured to previous versions of ANSI/ASSP Z359.14) being used with 3M™ DBI-SALA® Temporary HLLs, so long as a qualified person has previously made a determination regarding compatibility. However, for newer 3M™ DBI-SALA® SRLs manufactured to ANSI Z359.14-2021 or after August 1st, 2023, check your SRL labels to confirm MAF and AAF figures are compatible with your 3M™ DBI-SALA® Temporary HLL System, based on the IFU in conjunction with the expanded approvals of the preceding table. Also, confirm anticipated free fall in your application aligns with the parameters established in the preceding table (whether it is anticipated to be less than or equal to 2 feet, or greater than 2 feet) in order to follow the corresponding guidance for your HLL System. The qualified person is responsible for reviewing the specific HLL system IFU, specific connecting component IFU and utilizing this product advisory to determine system compatibility.

Notes:

- 1. Anticipated free fall is different from maximum allowable free fall which is listed on an SRL product label. In the event of a fall, product misuse due to incompatibility could result in severe injury or death. Again, consult your authorized qualified person(s)* as appropriate. Appendix A includes a list of 3M™ DBI-SALA® and 3M™ Protecta® SRL products now being certified to ANSI/ASSP Z359.14-2021 and their corresponding arrest force categories, as a reference only.
- 2. 3M may choose to publish differing ANSI vs. OSHA performance arrest force claims. In the case of HLLs being OSHA only products, as there is no published ANSI standard pertaining to this product category, connecting components are evaluated for compatibility with HLLs based on OSHA arrest force performance claims.
